- 1. <u>Call to Order and Roll Call</u>. Chairman Hamman, called the Water Trust Board ("WTB") meeting to order at 9:01 a.m. Roll call was taken, and a quorum was established.
- 2. <u>Approval of Agenda</u>. Member Forte made a motion for approval of the agenda, seconded by Member Russel. The motion passed unanimously by a voice vote.
- 3. <u>Approval of the May 5, 2022, Board Minutes</u>. Member Russel made a motion, seconded by Member Forte, to approve the minutes of the May 5, 2022, meeting. The motion passed unanimously by a voice vote.
- Water Trust Board Project Management Policies Recommendation. Ms. Angela Quintana, Senior Program Administrator

Recommendations for revisions to the Water Trust Board Project Management Policies ("Policies").

The Water Project Finance Act (the "Act") creates a 16-member board comprised of a diverse set of water users, advocates, and regulators whose duties include annually recommending to the legislature a list of projects to be funded from the Water Project Fund. Currently, estimates for WTB funding over the next several years approximate \$100 million per year. This increased funding comes at a time when federal funding for water and other infrastructure projects has also increased dramatically. This increase in funding means that shovel-worthy and shovel-ready projects have more options for funding, some of which may take less time to secure.

The Act mandates that NMFA provide staff support to the WTB, develop application forms and procedures, and make grants and loans recommended by the WTB. Importantly, the Act directs the WTB to rely on member agencies in carrying out the responsibilities of the WTB including 72-4A-5.1c which provides that "the board shall utilize the resources of its member agencies and entities whenever possible in implementing the state water plan" and 72-4A-7(B) which provides that "Plans and specifications for a water project shall be approved by the authority, after review and upon the recommendation of the State Engineer and the Department of Environment, before grant or loan disbursements to pay for construction costs are made to the qualifying entity." Member agencies, including those identified in the Act, are facing an increase in federal and state funding for programs they administer which will reduce the resources available to assist the WTB in carrying out its responsibilities.

At recent WTB meetings, Board members asked the Policy Committee to review the following areas of the policies prior to the next funding cycle (2023):

- A. Project Management Team current oversight/application requirements.
- B. Regulatory Compliance timelines.
- C. Match requirements for small/underserved entities.
- D. Rate paying constituents vs. rate paying systems.
- E. Financial capacity/loan determination.

The Policy Committee met on July 13, 2022, and July 27, 2022, to discuss and provide recommendations for revisions to the WTB Policies. Due to the estimated funding increase over the next several years, the recommendations for the revised Policies provide a wider net for applicant eligibility and flexibility for technical oversight.

The attached proposed Policies address the following subjects:

- Clarifying language, particularly as it relates to financial capacity
- Minimum application requirements
- Changes to loan requirements
- Changes to match requirements
- Applicant opportunities

Financial Capacity

Pursuant to the Act, loans or grants may be made only to qualifying entities that meet the requirements of financial capability to ensure sufficient revenues to operate and maintain a water project for its useful life and to repay the loan. As part of the financial analysis performed by the NMFA, applicants are required to submit information in determining financial capacity with regards to the repayment of a loan. Staff is recommending clarifying language to provide an overview of the financial analysis process as well as the financial responsibility of an applicant seeking funds from the WTB. The recommendations require applicants to be in good standing with the NMFA on its grants or loans to be deemed financially capable to receive WTB financial assistance and maintain a debt service coverage ratio of at least 1.0x during the life of the loan.

Minimum application requirements

The Project Management Team ("PMT") is an informal group of technical experts from the following agencies:

- NMED-Construction Programs Bureau ("CPB")
- Office of the State Engineer
- NM Department of Game and Fish
- NM Department of Agriculture
- NM Energy, Minerals and Natural Resources Department
- NM Department of Finance and Administration
- NM Finance Authority

The PMT voluntarily reviews applications and makes recommendations to the WTB Project Review Committee throughout the application process. In addition to reviewing the applications, NMED-CPB also provides technical project oversight on certain awarded projects through a Memorandum of Agreement with NMFA. Given the increase of funding it administers and difficulty in securing engineering staff, NMED-CPB has begun to scale back on the number of projects it will oversee from the recent 2022 awards. Because

of the increased funding and diminished capacity for technical oversight, staff recommends adjustments to several sections of the policies.

Appropriate planning is a vital part of the WTB process and planning will remain as part of the minimum application requirements. However, staff recommends considering a technical memorandum prepared by licensed engineer with cost estimates not older than one year may be accepted in lieu of a preliminary engineering report. The applicants' consulting engineer will also need to certify design completion (construction only projects) as part of the readiness application and provide updated construction cost estimates. In addition, to allow applicants additional time to meet regulatory compliance requirements, regulatory agencies will certify applicants' compliance with all relevant regulations as part of the project application. This will allow applicants to work directly with regulatory agencies much earlier in the process to meet the Readiness application deadline.

Loan requirement changes

As part of the financial responsibility of the applicant, loans or grants are made to qualifying entities that meet the requirements of financial capability to ensure sufficient revenues to operate and maintain a water project. The loan serves as evidence of commitment to the project and as a mechanism for NMFA to pay its administrative costs. The WTB allows an additional match in lieu of the loan component for water projects implemented by tribal applicants and for qualified <u>entities</u> that are not supported by rate-paying constituents. For those entities that have a rate paying constituency but whose projects may not have a specific rate-paying revenue source, staff recommends that the additional match in lieu of the loan be classified as: water projects implemented by tribal applicants and for qualified <u>projects</u> that are not supported by rate-paying constituents.

In addition, to assist smaller systems that may not have the financial capability to take on a loan, the NMFA may waive loan requirements for water projects when:

- i. The applicant serves fewer than 500 connections and has previously secured WTB funding for the same project: or
- ii. The project is to consolidate with another system.
- iii. To qualify for the loan waiver, the applicant must have implemented an asset management plan for the current and future maintenance, replacements, and repair of the system.

Match requirement changes

The WTB requires applicants to demonstrate project commitment in the form of minimum local matches based upon project type, size, and Median Household Income ("MHI"). In the instance where an applicant does not have the local match, they may take on an additional loan in lieu of the required match. For small water systems that may have difficulty in providing the required match, the Board may waive the match requirement when:

- i. The applicant serves fewer than 250 connections and has previously secured WTB funding for the proposed project as defined by planning documents: or
- ii. System upgrade is to consolidate with another system; or

- iii. System upgrade/expansion is to incorporate previously unserved customers (not for future development); and
- iv. Applicant has implemented an asset management plan for the current and future maintenance, replacement, and repair of the system.

Because of the increasing costs of construction, staff recommends the "Scale of Request" in determining the match requirement be adjusted in the Water Storage and Water Conservation categories to effectively lessen local match requirements. Staff also recommends the removal of the "soft match" as part of the local match category due to the arduous tasks associated with applicants providing adequate supporting documentation and staff reviewing those same documents.

Applicant Opportunities

To assist applicants in search of funding opportunities for construction-ready projects, staff recommends the following addition to the project selection recommendations:

The Board may consider awarding 100% grant to "design only" projects with the following conditions:

- i. The project serves or will serve fewer than 500 connections
- ii. Scope is limited to design only "design" is defined as necessary technical work required to prepare a complete and final set of plans and specifications ready to be bid for construction
- iii. Costs for design must be substantiated with a coordinating approved planning document
- iv. Grants for design may not exceed \$500,000.

The intent of the Policies and the above recommendations is to select projects that are fiscally sustainable, encourage a long-range approach to water management and regional participation, set standards for funding based on sound business practices, and support public health and economic vitality through comprehensive planning and investment in infrastructure, create systems that are hydrologically and fiscally sustainable that meet state and federal regulatory requirements and protect the state's investment in water by requiring accountability and stability.

The Policy Committee has reviewed these revisions and concurs with staff's recommendations. Staff recommends approval of the revised Policies as presented.

(Member Sloane joined the meeting at 9:30 a.m.)

5. Member Lucero made a motion, seconded by Member Van Dyke, to approve the Water Trust Board Project Management Policy changes as presented. The motion passed unanimously by a roll call vote.

(Chairman Hamman left the meeting at 9:33 a.m. due to a prior commitment and Vice Chairman Forte assumed the Chairman role).

6. WTB 2023 Application Funding Cycle Overview. Ms. Angela Quintana, Senior Program Administrator

The 2023 WTB application cycle began with the Notice of Intent ("NOI") Period, August 1-15, 2022. The NOI form notifies entities of the anticipated funding available for the current cycle and provides staff with the current needs. Applicants may continue to submit NOI's up until the closing of the application on September 23, 2022.

The estimated available funding for the 2023 cycle is approximately \$93.3 million with a 15% cap of \$13.9 million. Per WTB policy, applicants may not receive more than 15% of the available funds in any year. NMFA staff will provide an application training (via virtual) on September 19, 2022, which will include policy changes.

The online project application will be open from August 25 - September 23, 2022. Applications will be reviewed for entity and project eligibility and evaluated by the Project Management Team: NM Environment Department, NM Department of Energy, Minerals and Natural Resources, NM Department of Agriculture, NM Department of Game and Fish, Office of the State Engineer, and NM Finance Authority. The applications will be evaluated on the WTB established criteria:

- Health & Safety
- Plan & Design
- Regional Water Plan
- Local Contribution
- Readiness
- Regionalization
- Other (Emergency, Economic Protection, Water Quality Improvement, Habitat Recovery, etc.)
- Preliminary Spenddown*

The WTB will give applicants an opportunity to present their proposed projects. Project presentations are scheduled for October 20, 2022 (Virtually). The Board will also consider any waiver requests at this meeting.

Since 2016, the amended WTB rules provide those applications submitted by qualified entities for qualified projects will be evaluated prior to the WTB recommending projects to the Legislature. Based on the evaluations, the Project Management Team along with the NM Department of Finance and Administration and staff from the Legislative Finance Committee will make recommendations for potential funding to the Project Review Committee for the Board's consideration on November 8, 2022. (NMFA Legislative Oversight meeting scheduled for November 10, 2022) Those applicants that are recommended to the Legislature for authorization will be invited to complete a readiness application that gauges regulatory and policy compliance. Staff will provide a WTB Readiness Application Training in December prior to the Readiness Application opening on December 12, 2022 – January 27, 2023.
