- 1. Call to Order and Roll Call. Chair Papen called the meeting to order at 10:05 a.m. A quorum was established.
- **2. Approval of Agenda.** Member Deal moved, seconded by Member Billingsley, to approve the agenda. The motion passed 6-0.
- **3. Approval of Board Minutes.** Member Deal moved, seconded by Member Billingsley, to approve the May 24, 2023, Minutes. The motion passed 6-0.
- **4. Nominating Committee Report.** (Committee members are Mr. Jay Armijo, Ms. Dora Batista, and Ms. Priscilla Lucero)
 - **4.1 Update on Activities.** Member Lucero reported the Nominating Committee met to consider nominations for Chair, Vice Chair, and Secretary.

- 6. Consideration and Approval of the Colonias 2024 Application Timeline.
 - 6.1 Ms. Quintana presented the 2024 application timeline. The application cycle will open with the submittal of a notice of intent on January 8-19, 2024. The on-line application cycle will open on January 29 through March 8, 2024. Compliance and technical review and scoring will be conducted, and proposed awards by this Board are anticipated to take place in May 2024. NMFA staff requests a motion to approve the timeline.

Member Deal moved, seconded by Member Dow, for approval of agenda item 6.1. The motion passed 6-0.

- 7. Update on 2022 Colonias Closing.
 - 7.1 **Update on 2022 Colonias Closing.** Ms. Quintana presented an update regarding the seven projects that are unable to secure funding from the 2022 award because they are awaiting USDA consent for additional debt and two projects waiting on a JPA agreement. The two projects are on schedule to obtain the JPA prior to the December meeting. Pursuant to the Colonias Infrastructure Fund Policies Section 6.3 Reallocation of Declined or Rescinded Financial Assistance Awards, the Board may rescind the funds for failure to secure the consent of USDA (or any other funder), if required, to enter into a financial assistance agreement. A balance of \$3.7 million is from the unsecured

2022 awards. . NMFA staff will provide recommendations on those projects that are unable to move forward at the next Colonias Board meeting in December. Discussion ensued regarding USDA consent. NMFA staff answered questions by the Board.
