- **1.** Call to Order and Roll Call. Chair Anderson called the meeting to order at 10:01 a.m. A quorum was established.

4. Water Trust Board ("WTB") Amended Rules.

**4.1 Approval of Resolution to Initiate Amendment to Rules.** Angela Quintana presented the resolution initiating a rulemaking procedure under the State Records Act to consider amendments to the WTB rules. # 6. NM Unit Fund ("NMUF") Pilot Cycle Policy.

**6.1 Approval of Timeline/Implementations of the NMUF Application.** Michael Vonderheide presented the NMUF application requirements and evaluation criterion. The policy outlines eligible entities and eligible projects which may fund planning and design components for water utilization projects that meet water supply demands in the Southwest Region. NMFA staff on behalf of the WTB will evaluate submitted applications against the articulated application criteria contained in the NMISC pilot cycle policy. Discussion followed with staff and the Interstate Stream Commission ("ISC") Director answering questions from the Board. The Director of the ISC thanked the WTB and NFMA staff on their collaboration on this project. Chair Anderson proposed to approve the policy and application with the potential of fine tuning the language within the policy and application as staff receives feedback on the first round.
