- 1. Call to Order and Roll Call. Chair Papen called the meeting to order at 10:02 a.m. A quorum was established.
- 2. Approval of Agenda. Member Martinez moved, seconded by Member Segura, to approve the agenda. The motion passed 6-0.
- 3. Approval of Board Minutes.
 - 3.1 Member Roybal moved, seconded by Member Baca-Argabright to approve the May 15, 2025, Board meeting minutes. The motion passed 6 0.
- 4. Report from Nominating Committee.

4.1 Report from Nominating Committee. Member Lucero reported that Mary Kay Papen has stepped down from being Chair of the Colonias Infrastructure Board but will remain on the Board. The nominating committee is recommending the election of officers as follows; Janice Baca-Argabright as the new Chair; Jose Luis Segura as Vice Chair and Marquita Russel as Secretary.

- 5. Election of Officers.
 - **5.1 Election of Officers.** Janice Baca-Argabright as the new Chair; Jose Luis Segura as Vice Chair and Marquita Russel as Secretary.

Member Roybal moved, seconded by Member Martinez to approve item 5.1 electing the new officers of the Board. The motion passed 6 - 0.

- 6. Construction Cost Overrun Update.
 - **6.1** Construction cost overrun update: Town of Silver City CIF-6437; San Pablo MDWCA CIF-6435. Staff presented an update for the Town of Silver City ("Town") and San Pablo MDWCA ("Association"). The Association was awarded funds in 2024 for wastewater system improvements, and secured full project funding on May 16, 2025, after delays related to USDA consent. The project went to bid, with the lowest bid coming in just under available funding, leaving no contingency allowance. To address this, the Association requested an additional \$240,000 and committed to providing additional matching funds instead of securing further USDA loans to avoid further delays.

Similarly, the Town was awarded funding in 2024 for a new lift station and force main, secured its funding on March 21, 2025, and requested an additional \$526,308 to move forward with awarding the base bid and completing the project, citing concerns over delays and rising costs if alternative funding were sought.

At its July and August 2025 meetings, the NMFA Board approved the recommended additional funding \$240,000 as a 100% grant for Project No. CIF-6435 and \$526,308 as a 10% loan 90% grant for Project No. CIF-6437.

- 7. Approval of Resolution in Change of Award to Different Entity.
 - 7.1 Approval of Resolution to reflect change in 2024 CIF project # CIF-6409 from Camino Real Regional Utility Authority ("CRRUA") to City of Sunland Park. Staff provided funding background and explained the Joint Powers Agreement ("JPA") between the two entities. Recently, the City of Sunland Park ("City") received notice that the Dona Ana County intends to terminate the JPA, triggering a four-year transition period for dividing assets and liabilities.

CRRUA has been responsible for managing water and wastewater services in the region but has recently faced scrutiny over water quality issues, including arsenic exceedances, and poor public communication. The current project is located within the City's municipal boundaries, and the lift

station is considered critical to public health and environmental safety. Concerns were raised that administrative uncertainty could cause delays, posing serious environmental risks to residents of the Riverside subdivision and potentially impacting cross-border areas.

With the City's concurrence, CRRUA requested to transfer Project No. CIF-6409 to the City. A resolution has been prepared to update the original certification of need to the State Board of Finance, as approved by the CIB in May 2024. Staff recommended approval of the resolution to certify the change in awardee from CRRUA to the City for Project No. 6409. Discussion ensued with staff answering questions from the Board.

Member Papen moved, seconded by Member Martinez to approve item 7.1 as presented. The motion passed 6 - 0.

8. Approval of 2025 CIF Second Iteration Awards.

8.1 Recommendation of 2025 Colonias Infrastructure Fund Awards Second Iteration.

For the 2025 cycle, \$80.57 million was available from severance tax bonds. On May 15, 2025, the CIB awarded \$51.2 million to 32 projects. Eleven applications from four entities were not certified due to regulatory non-compliance, prompting the Board to extend the compliance deadline to August 8, 2025, and postpone decisions on the remaining \$29.36 million until September. Staff prioritized remaining projects based on original evaluations and confirmed applicants' funding needs, leading the City of Deming to withdraw six of its eight applications. Additionally, the 2025 Legislature passed HB493, the Public Finance Accountability Act, establishing criteria for grantees to remain eligible for funding if audit or reporting requirements are unmet.

NMFA Counsel presented for approval the Resolution, Notification, and Certification of need for issuance of severance tax revenue bonds for additional qualified projects. Counsel recommended approval of the documents relating to the severance tax revenue bonds.

Member Papen moved, seconded by Member Martinez to approve item 9.1 as presented. The motion passed 6 - 0.

- 10. Approval of Additional Funds for the 2025 CIF Awarded Projects.
 - 10.1 Approval of Additional Funds for the 2025 CIF Awarded Projects. Staff presented a list of projects that, due to an increase in construction costs, three entities with a total of five projects anticipate a shortfall in funding to complete their projects. See the breakdown below.
